The workshop is designed for archivists, librarians, museum staff, and educators, empowering them to master disaster prevention measures and train their peers in safeguarding unique records and ensuring their accessibility, particularly in vulnerable contexts.



#### **About UNESCO'S DRM Toolkit**



Government Public Library Prayagraj, earlier known as Allahabad Public Library is situated at Prayagraj, a historical and holy city of Uttar Pradesh. The beautiful building of this library is an architectural marvel of the eighteenth century. It has been a sacred place of intellectual activities since its very inception. The library was established in 1864 by the approval of British governor. This is one of the oldest public libraries not only in Uttar Pradesh but in India also. The library is one of the world's magnificent repositories of cultural heritage and treasure-house of knowledge. It is giving positive thrust to book-culture and related activities. From the very inception of this library, several celebrities from India and abroad visited this magnificent collection and placed on record their deep sense of appreciation. Many citizens who became great name in India and even in the world have been among the borrowers of this library. The library has a vast collection of study materials which are not to be found anywhere else. The printed book section has a unique importance as thousands of rare books which are now out of print and may be regarded valuable as manuscripts, an important material for research work. There is good collection of rare & valuable books, historical documents, manuscripts, bound volume of old newspapers/magazines, new books and other study materials in Hindi, English, Sanskrit, Urdu, Arabic, Persian, Bengali, French etc. Library stock consists of approximately 1.25 lakh books on a variety of subjects.
